#### **CALL TO ORDER**

Pitzer gave an update on Pickleball Courts stating that the courts had been cleaned and prepped for resurfacing. He said that Good Neighbor Fence will be lowering the fencing at the courts.

duChemin said that work has been done at Pendergast Field and that Centerline Fields have a few water leaks and they also need some filling. He said that younger kids are playing at the new West field at Henning Park.

duChemin said that sprinklers have been tested at soccer fields and Comstock Turf has been working with Wendy at AYSO regarding mowing and maintaining fields.

Smith was absent and will follow up on Memorandum of Understanding between NCPRC and NCRA at the July meeting.

Board discussed "draft" NCRA Field Use Policy and duChemin said it still needs modifications. Board discussed signage needed at baseball fields and duChemin said that signage needs contact information for those interested in field use.

Goodin was absent and will have questions and draft of suggested changes regarding NCRA Recreation Plan at the July meeting.
